


# Network Code on Harmonised Transmission Tariff Structures for Gas - Analysis of the consultation documents


Commission Regulation (EU) 2017/460 of 16 March 2017 establishes a Network Code on Harmonised Transmission Tariff Structures for Gas (NC TAR).


Article 26(1) of this network code requires NRAs or TSOs to carry out one or more consultations regarding the tariff structure. Article 27 of the NC TAR requires the Agency to analyse the consultation documents.


The consultations will run in 2018 and 2019. On this page, all the Agency Reports that analyse the consultation documents will be published.


Within five months following the end of the final consultation, the NRA should take a motivated decision. All decisions have to be taken by 31 May 2019.
