ACER launches today a public consultation on a common schema for the disclosure of inside information. For that purpose, the Agency is publishing a consultation paper providing recommendations on a common minimum standard necessary to ensure fair, effective and transparent communications of information that is likely to significantly affect wholesale energy prices. The deadline for providing comments and responses to the consultation's questions is 26 June 2015, 12.00 noon, Central European Time. Find out more [here](#).

Energy infrastructure projects in the EU: How to ensure they benefit all Member States?

Within a series of actions carried out by ACER to bring its work closer to the EU citizens, the Agency has recently published a [Citizens' Summary](#) on Cross-Border Cost-Allocation (CBCA) decisions on Projects of Common Interest (PCI) for Energy Infrastructure in the EU. The exact allocation of the costs between the Member States involved in a certain PCI is generally decided by the relevant National Regulatory Authorities (NRAs). If they do not reach an agreement within six months, the case is conferred to ACER to decide. The Agency has so far decided on the Gas interconnection Poland Lithuania (GIPL) and on the Lithuanian part of the electricity interconnection between Lithuania and Poland (LitPol).
