

**DIRECTOR DECISION 2018-41**

**of 21 December 2018**

**on the extension of the validity of reserve lists of successful candidates**

THE DIRECTOR OF THE AGENCY FOR THE COOPERATION OF ENERGY REGULATORS,

Having regard to Regulation (EC) No 713/2009 of the European Parliament and of the Council of 13 July 2009 establishing an Agency for the Cooperation of Energy Regulators<sup>1</sup>, and, in particular, Articles 1(1), 17(5) and 17(9) thereof,

Having regard to the Staff Regulations of Officials of the European Communities and the Conditions of Employment of Other Servants of the European Communities (CEOS), laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>2</sup>, and, in particular, Articles 12(5) and 82(6) of the CEOS,

Having regard to Decision AB No 8/2015 of the Administrative Board of the Agency for the Cooperation of Energy Regulators of 11 June 2015 on the adoption of general implementing provisions on the procedures governing the engagement and the use of temporary staff under Article 2(f) of the CEOS, and, in particular, Article 11 thereof,

Having regard to Decision AB No 11/2011 of the Administrative Board of the Agency for the Cooperation of Energy Regulators of 1 June 2011 on the adoption of general implementing provisions on the procedures governing the engagement and the use of contract staff at ACER, and, in particular, Article 5(2)(e) thereof,

Whereas:

- (1) The engagement of staff from reserve lists has implications in terms of budget and timing of entry into service. In this regard, reserve lists of successful candidates shall ensure the maintenance of profiles matching the foreseeable organisational needs, human resources planning and requirements of the Agency for the year 2019.
- (2) It is in the interest of the service to extend reserve lists of successful candidates, so as ensure the proper and cost-effective functioning of the Agency to meet its mission and objectives, where the Agency foresees a need for the year 2019.
