

## Open call for the European associations of stakeholders to be involved in the roundtable meetings on REMIT implementation

Ljubljana, 18 December 2023

Subject: Invitation to participate in ACER's REMIT implementation roundtables with stakeholders

Dear Sir or Madam,

In the context of the implementation of Regulation (EU) No 1227/2011 on wholesale energy market integrity and transparency (REMIT) and based on the positive experience over the past years, the European Union Agency for the Cooperation of Energy Regulators (ACER) will organise stakeholder roundtable meetings with European Associations of Energy Market Participants on REMIT implementation in 2024 and 2025.

The purpose of the stakeholder roundtable meetings will be to consult on material updates of the REMIT reporting user package and to exchange views with the relevant parties. Stakeholders will be invited to comment on selected questions on data collection and other compliance issues under REMIT and its Implementing Regulation, whenever further consideration is deemed useful.

All attendees will be required to contribute to the roundtable meetings in order to sustain their eligibility and receive invitations to the meetings. The roundtable meetings should not be regarded as an opportunity to receive guidance from the ACER.

Roundtable meetings organised for the European Associations of Energy Market Participants will focus on transaction reporting guidance and data quality, while also discussing the transaction reporting aspects of the potential future revision of the REMIT Implementing Regulation. ACER aims at ensuring a balanced participation of different constituencies at EU level. This is why this call is limited to European associations of energy market participants representing energy market participants from several EU Member States. National associations may participate in the roundtable meetings through the European association(s) of which they are members.

In addition, ACER will continue to organise roundtable meetings with Organised Market Places, Inside Information and Transparency Platforms and Registered Reporting Mechanisms registered with ACER. Entities published in the respective lists on the <u>REMIT Portal</u> are automatically eligible for participation in the roundtable meetings and are not required to register for the 2024-2025 roundtables.

Additional roundtable meetings dedicated to other stakeholder groups may be considered if needed.

The deadline for applications is **19 January 2024**. Applications received after the deadline will not be considered.

In order to ensure transparency and openness, the organisations to which applicants belong should be registered in the EU Transparency Register at the following link: <u>Transparency Register (europa.eu)</u>.

The roundtable meetings may take place in the form of in-person or virtual meetings. In-person roundtable meetings can only accommodate a limited number of participants. Therefore, in the interest of admitting as many stakeholders as possible while also ensuring variety, no more than two participants per organisation may normally participate in the in-person roundtable meetings.

Further information about the dates, formats and draft agendas of the meetings will be provided to registered participants in due course.
