ACER will invite the RRMs to join the UTI group in the next RRM User Group meeting.

1. Discussion on transaction reporting issues

ACER provided updates on recent developments. It was mentioned that the second phase of data collection had been running smoothly. Updates were provided regarding the status of RRM registration. ACER indicated that an updated version of the Q&As and FAQs on fundamental data would be published in the upcoming days.

ACER informed the meeting participants that the core IT work for the reporting had been completed. The collection of inside information had been postponed to 1 January 2017.

As was communicated in the last REMIT Quarterly edition, ACER had applied a new policy about query management: in the future, only non-repetitive queries would be followed up. The meeting participants were also informed that there would soon be a new Head of the Surveillance and Conduct Department.

The group discussed the differentiation of standard and non-standard contracts. ACER said that the list of standard contracts was being revised. It was also indicated that the differentiation of Table 1 and Table 2 can be further discussed in the future and that the AEMPs are willing to contribute their input.

The AEMPs reported issues in the relationships between OMPs, MPs and RRMs. ACER mentioned that guidance has been provided on that matter through the Q&As on REMIT.

With regard to the delivery point, ACER mentioned that they would draft a guidance note with the support of external experts.
