

ACER draft amendments to the Network Code on Requirements for Generators

Introduction

This consultation aims to present ACER's draft amendments to the Commission Regulation (EU) 2016/631 of 14 April 2016 establishing a **Network Code on Requirements for Grid Connection of Generators** ('NC RfG').

Background

Important developments in the policies of decarbonisation of the European Union (EU) energy and transport sectors have taken place since the inception of the development of the first European Grid Connection Network Codes (GC NCs) in 2012.

In the framework of the Grid Connection European Stakeholder Committee (GC ESC), the European Commission proposed for ACER to initiate the process towards the amendment of the existing GC NCs in September 2022. The amendment process, as presented to the GC ESC is outlined in the Figure below:



Following the scoping phase, ACER published the Policy Paper on the revision of the network code on requirements for grid connection of generators and the network code on demand connection in September 2022. The Policy Paper aimed to transparently indicate to stakeholders the key policy areas in which amendments were to be expected.

As a next step, ACER launched the Public Consultation to gather stakeholders' views and concrete amendment proposals regarding the GC NCs. The stakeholders could submit their inputs by 21 November 2022.

After the evaluation of stakeholders' inputs, ACER has formulated its own proposal for the amendments of the GC NCs which is subject to this public consultation.

(9)	<p>We deem there is a lack of clarity in the notion of electricity storage integrated to a power-generating module. In particular, the proposal introduces the concept of electricity storage used solely for the purpose of meeting the requirements of the Network Code that is very complex to discriminate in a practical case. We suggest to remove this reference since it could introduce uncertainties in the application of the requirements, without any concrete added value. Considering also the complexity behind a clear definition of integrated energy storage, where needed, this notion could be defined by TSOs at national level, without particular impacts on the application of the NC RfG.</p>	<p>The significance of power-generating modules should be based on their size and their effect on the overall system. Synchronous machines should be classed on the machine size and include all the components of a generating facility that normally run indivisibly. An installation containing a set of synchronous machines that cannot be operated independently from each other, such as combined-cycle gas turbine installation, should be assessed on the whole capacity of that installation. Non-synchronously connected power-generating units of the same underlying technology, where they are collected together to form an economic unit and where they have a single connection point should be assessed on their aggregated capacity. Moreover, to ensure an appropriate harmonisation or rules for mass-market products, capacities of units of different classes, for instance, photovoltaic, electricity storage, combined heat and power installations, or V2G electric vehicles, should not be aggregated for the purpose of the determination of significance.</p>

(**)	<p>We point out that a clear definition of a fully autonomous energy island is not present in the Regulation. We suggest to remove this reference since it could introduce uncertainties in the application of the requirements, without any concrete added value. In alternative, this concept should be better clarify in the sense that derogation from RfG requirements should be granted only to fully stand alone PGMs not operating in parallel with any portion of the electrical system (off-grid systems).</p>	<p>Power-generating modules are subject to the requirements of this Regulation regardless of whether they are part of an energy community as defined in Regulation (EU) 2019/943, another entity, or a form of system users aggregation.</p>

Article 5	<p>As the Italian transmission system operator, we fully support ACER proposal not to harmonize the banding value among type A/B PGMs. Indeed, ceteris paribus, a simple harmonization to an higher threshold would negatively affect those TSOs, like Terna, that currently apply a lower band among type A/B PGMs because of specific system needs.
