

## **Minutes of the Review Panel meeting of the Administrative Board and composite 2026 assessment report on potential conflict of interest**

### **(the meetings on the Review Panel of 26 February 2026 and of 6 May 2026)**

The Review Panel assessed the annual Declaration of Interests (“DoI”), Curricula Vitae (“CV”) and Declarations of Commitments (“DoC”) submitted by the members and alternates of the Administrative Board (AB) of the Agency for the Cooperation of Energy Regulators (ACER) to comply with the obligation of acting independently when carrying out their duties.

The AB members and alternates were informed about the upcoming annual conflict of interest exercise by the AB Secretariat on 12 December 2025 with the aim of its official launching on 1 January 2026. Members were expected to submit the required documents by email by 31 January 2025.

### **The composition of the 2026 Review Panel**

The members of the 2026 Review Panel were appointed by the AB at its 70<sup>th</sup> meeting on 11 December 2025. The 2026 Review Panel is composed of **Mr Bogdan Chirițoiu**, the AB Chair, **Mr Tomasz Dąbrowski**, the AB Vice-Chair, and **Mr Frédéric Versini**, European Commission member. **Ms Karoline Narodoslowsky** was appointed as an alternate member of the Review Panel reviewing the individual cases of Mr Chirițoiu, Mr Dąbrowski and Mr Versini.

### **The assessment of the Review Panel**

The Review Panel noted that all AB members and alternates submitted their 2026 Declarations of Interest, CVs, and Declarations of Commitment. As the mandates of certain members (Ms Herczog and Mr Spiridonovs) and alternates (Ms Thomsen and Mr Nyikos) expired in January 2026, they were nevertheless invited to submit the required documents for the period of January.

The members of the Review Panel were asked to assess the submitted documents in line with the following decisions that are laying down the policy for the prevention and management of conflict of interest for the ACER AB:

- **Decision N° 02/2015 of the AB of the Agency for the Cooperation of Energy Regulators of 31 January 2015 laying down a policy for the prevention and management of conflict of interest.** The decision sets out criteria to be considered in the assessment such as family ties, financial investments in any relevant commercial entity (including any investment in the energy sector) and other potential interests including, among others, professional relationship such as employment and consultancy, membership of the managing body or advisory body, other membership and affiliations.

- **Decision N° 16/2022 of the AB of the Agency for the Cooperation of Energy Regulators of 14 December 2022 laying down the Guidelines on the prevention and management of conflicts of interest for the Administrative Board and the Board of Appeal of the Agency for the Cooperation of Energy Regulators.**

The assessment of each AB member/alternate was performed individually by each member of the Review Panel and was followed by a meeting, which took place on 26 February 2026. The assessments of the individual cases of the three Review Panel members was submitted by the alternate member on 26 February 2026.

Based on the interests declared by the members and alternates, individual assessments and further discussions at the meeting, the Panel assigned to each member and alternate of the following risk levels:

- Level 1: No relevant interests declared
- Level 2: Relevant interests declared (e.g., in the energy sector) but which do not have (and are not expected to have any for the year following the declaration) direct influence on the general decision-making process of the Administrative Board or which are not directly impacted by the Board's decision-making
- Level 3: Interests declared pertaining directly to the field of competence of the Board

### **Outcome of Review Panel Assessment**

The Review Panel assessed most members and alternates as presenting risk levels 1 and 2, which do not require further action. One alternate was assessed as presenting risk level 3.

In accordance with Article 11.5 of AB Decision 16/2022, the Review Panel informed the alternate concerned on 26 February 2026 that a potential conflict of interest had been identified, in light of his current employment with an NRA (as outlined in the table above), and invited him to submit observations within 14 calendar days (by 12 March 2026).

The Review Panel will assess any observations received and determine the appropriate next steps in line with AB Decision 16/2022. If necessary, the report will be updated to reflect the outcome.

The Review Panel reminded all members and alternates, especially the one with the identified risk level 2, about the obligation to inform the Secretariat of a potential conflict of interest in connection to any item on the agenda of the meeting, which could be considered as prejudicial to his independence and impartiality. It was reiterated that the latter would be checked also at the beginning of each AB meeting or launch of a written procedure.

The members and alternates were also reminded about the obligation to inform immediately the AB Secretariat of any new circumstances not covered by the existing declarations, but which might arise to a potential conflict of interest.

In line with the Article 6.6 of the AB Decision 16/2022, the 2026 Assessment report on potential conflict of interest of the AB members and alternates will be published on the website of the Agency.
