

Overview

This document provides a view of the validation rule configuration for ARIS DCI environments (testing framework and production) accessible to RRM's and used for REMIT data reporting to the Agency.

The testing framework and production environments are used by RRM's for testing purposes and for official REMIT data reporting, respectively.

The tab 'validation rules' shows all current validations.

The document was last updated on 28 November 2022.

Submissions should be aligned to the validations.

The Validation Rules column shows the Rule code followed by Short description and Relevant Schemas to which it applies.

The last two columns show if the validation rule has been enable (green, marked as ✓) or disabled (red, marked x) in the respective ARIS-DCI environment.

Validations shown as DISABLED - these rules will be ignored.

Validations shown as ENABLED - these rules are active.
