

## **DIRECTOR DECISION 2019-35**

#### of 29 October 2019

## establishing the Public Holidays for the year 2020 at the European Union Agency for the Cooperation of Energy Regulators

THE DIRECTOR OF THE EUROPEAN UNION AGENCY FOR THE COOPERATION OF ENERGY REGULATORS,

Having regard to Regulation (EU) 2019/942 of the European Parliament and of the Council of 5 June 2019 establishing a European Union Agency for the Cooperation of Energy Regulators<sup>1</sup> (hereafter referred to as the "Agency"), and, in particular, Article 24 thereof,

Having regard to the Staff Regulations of officials and the Conditions of Employment of other servants of the European Communities (hereinafter "CEOS"), laid down by Council Regulation (EEC, EURATOM, ECSC) No 259/68<sup>2</sup>, and, in particular, Article 61 of the Staff Regulations and Articles 16 and 91 of the CEOS,

Having regard to Commission Decision C(2013)9051 introducing implementing provisions on leave, and, in particular, III.f and III.g thereof,

After consulting the Staff Committee on 18 October 2019,

Whereas:

- (1) Every year the Agency issues a list of public holidays for the following calendar year.
- (2) Following Commission Decision C(2013)9051, the total number of public holidays shall be between 17 days (minimum) and 19 days (maximum),

### HAS ADOPTED THIS DECISION:

### Article 1

The following 19 days will be considered as public holidays for the Agency in 2020, provided that the needs of the service would not require otherwise:

#### Article 2

Without prejudice to the schedule of holidays for 2021, Friday, 1 January 2021 will be holiday.

#### Article 3

Staff members may choose to work on the following 3 days: Maundy Thursday (09.04.2020), Good Friday (10.04.2020) and the day following Ascension Day (22.05.2020), which are considered as public holidays. The number of days worked will be added to the annual leave balance of the current year (2020). Staff members working during public holidays must get prior approval from the immediate supervisor by submitting a request through the respective IT application. Teleworking days are to be treated as normal working days conferring entitlement to this flexibility. The Director or the respective Head of Department shall verify whether his/her staff members worked during the public holiday, as approved.



# Article 4

This Decision shall enter into force on the day of its adoption and shall be communicated to all staff.
