Thank you for letting FGSZ know about the public consultation. Please see attached FGSZ's answers (which are not confidential).

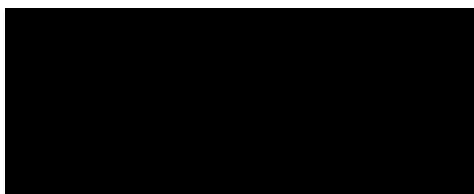
With regard to the below timeline, please be informed that we have already unofficially contacted independent auditors in the domain enquiring about their availability. Based on the answers, the IT audit (taking into account the necessary procurement procedures as well) can take place between the middle and end of June 2019, with a latest deadline of 30 June 2019, provided that the scorecard is finalised and known by the middle of May 2019. We kindly ask you to take this into account when requiring the audited scorecard from the booking platform operators.

It is also mentioned in the answer but we would like to underline here as well that more information is required on the case study in a timely manner so that we are able to meet your expectations. We have to admit that from the consultation paper we could not decipher the scope and complexity of the case study.

We are looking forward to your reply and the next steps in the procedure.

To facilitate the Agency's decision making on the selection of a single booking platform to be used at the Mallnow interconnection point and at GCP VIP, the Agency wants to make your booking platform aware that a public consultation was launched (find the consultation notice [here](#)). The Consultation Notice gives information on how the Agency intends to select the booking platform.

The Agency would like to make you aware that the letter requesting your offers, of which we will circulate shortly a draft version, will indicate that the offer needs to be underpinned with:

- a case study to be prepared by the platform;
- a self-assessment of the IT requirements. The self-assessment has to be countersigned by an independent auditor (to be contracted by the platform).

The formal letter requesting the offers for offering the services at one or both interconnection points will be circulated indicatively on 10 May 2019 and offers should be submitted by 31 May 2019 (indicatively).
