## Changes from Original to Corrigendum version (February 2016)

All the changes (indicated in *italics*) introduced vis-à-vis version 1 are listed below by heading number and title of version 1.

#### 2.4.1 Intervention in retail price setting mechanisms

The first sentence of the paragraph 214 on page 88 has been changed as follows:
