

**DECISION No 20/2025**

**OF THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY  
FOR THE COOPERATION OF ENERGY REGULATORS  
of 12 December 2025**

**amending Decision AB No 08/2024 adopting the final Single Programming  
Document ('SPD') 2025-2027 including the Establishment plan 2025 and the  
budget of the Agency for the Cooperation of Energy Regulators for the financial  
year 2025**

THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR THE  
COOPERATION OF ENERGY REGULATORS,

Having regard to Regulation (EU) 2019/942 of the European Parliament and of the  
Council of 5 June 2019 establishing a European Union Agency for the Cooperation of  
Energy Regulators(recast)<sup>1</sup> and in particular, 17(a), 19(f) and 33(9) thereof,

Having regard to Decision AB No 08/2019 of the Administrative Board of the Agency for  
the Cooperation of Energy Regulators of 21 June 2019 on the adoption of the Financial  
Regulation of the Agency for the Cooperation of Energy Regulators, and in particular,  
Article 34 thereof,

Having regard to Decision AB No 7/2020 of the Administrative Board of the European  
Union Agency for the Cooperation of Energy Regulators of 17 June 2020 on the adoption  
of the Rules of Procedure of the Administrative Board of the European Union Agency for  
the Cooperation of Energy Regulators, as amended by Decision AB No 2/2023,

Whereas:

- (1) On 11 December 2024, the Administrative Board adopted the budget of the  
European Union Agency for the Cooperation of Energy Regulators (hereinafter 'the  
Agency'), for the financial year 2025<sup>2</sup>.
- (2) The amount of revenues from REMIT fees and charges envisaged for the financial  
year 2025 at the time of the budget adoption was EUR 21,067,920.00, while the  
total amount of debit notes issued in January 2025 pursuant to the rules laid down  
in Commission Decision (EU) 2020/2152<sup>3</sup> amounts to EUR 13,298,000.00.

- (3) In addition, the Agency charged interests for late payments of the REMIT fees in the amount of EUR 728.57, in accordance with Article 64 of the Financial Regulation of the Agency.
- (4) Moreover, during 2025, the Agency has also received additional EUR 20,000.00 in registration fees from new Registered Reporting Mechanisms whose applications were processed during that period.
- (5) Furthermore, on 14 September 2025 Commission Decision (EU) 2025/1771<sup>4</sup> entered into force. Pursuant to Article 10 of the same Decision, the Agency is entitled to send each RRM an invoice for a surcharge which must be calculated in accordance with same Article; the total amount of invoices issued by the Agency amounts to EUR 7,546,664.18.
- (6) Since the above-mentioned established revenues amount to EUR 20,865,392.75, the Agency's revenue from REMIT fees and charges envisaged for the financial year 2025 established in Decision AB No 08/2024 needs to be adjusted downward, by calculating the difference between the initially planned revenue in the amount of EUR 21,067,920.00 and the revenue received in the amount of EUR 20,865,392.75.
- (7) The amount resulting from the calculation mentioned in Recital (6) above, i.e. EUR 202,527.25, should be reduced under Title 3, which pertains to fee-related expenditures for the Agency's REMIT IT systems.
- (8) No amendment is required to the Establishment plan.
- (9) In light of the above, it is therefore appropriate to amend Decision AB No 08/2024 of the Administrative Board of the Agency of 11 December 2024,

HAS ADOPTED THIS DECISION:

*Article 1*

Annex I to Decision AB No 08/2024 of the Administrative Board of the European Union Agency for the Cooperation of Energy Regulators of 11 December 2024 on adopting the final Single Programming Document ('SPD') 2025-2027 including the Establishment plan 2025 and the budget of the Agency for the Cooperation of Energy Regulators for the financial year 2025, is replaced by Annex I to this Decision.

*Article 2*

1. This Decision shall enter into force on the date of its adoption.
