**OF THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR
THE COOPERATION OF ENERGY REGULATORS**

of 15 February 2022

**on the appointment of one Member of the Board of Regulators of the European Union
Agency for the Cooperation of Energy Regulators**

THE ADMINISTRATIVE BOARD OF THE EUROPEAN UNION AGENCY FOR THE
COOPERATION OF ENERGY REGULATORS,

Having regard to Regulation (EU) 2019/942 of the European Parliament and of the Council of 5 June 2019 establishing a European Union Agency for the Cooperation of Energy Regulators¹, and, in particular, Article 19(1)(b) thereof,

Having regard to Decision of the EEA Joint Committee No 93/2017 of 5 May 2017 amending Annex IV (Energy) to the EEA Agreement [2019/205]², and, in particular Article 1(5) thereof,

Having regard to Decision No 05bis/2010 of the Administrative Board of the European Union Agency for the Cooperation of Energy Regulators of 21 September 2010 on the Delegation to the Chair of the powers to appoint new members of the Board of Regulators,

Whereas:

- (1) The Agreement on the European Economic Area incorporates Regulation (EC) No 713/2009 of the European Parliament and of the Council of 13 July 2009 establishing an Agency for the Cooperation of Energy Regulators, Regulation (EC) No 714/2009 of the European Parliament and of the Council of 13 July 2009 on conditions for access to the network for cross-border exchanges in electricity, and Regulation (EC) No 715/2009 of the European Parliament and of the Council of 13 July 2009 on conditions for access to the natural gas transmission networks.
- (2) In light of the above, pursuant to Decision of the EEA Joint Committee No 93/2017 of 5 May 2017, the national regulatory authorities of the EFTA States, as well as the EFTA Surveillance Authority, shall participate fully in the work of the European Union Agency for the Cooperation of Energy Regulators, and in all its preparatory bodies, including working groups, committees, task forces of the Agency and the Board of Regulators, without the right to vote.
- (3) On 28 January 2022, the EFTA Surveillance Authority (ESA) informed the Agency of its proposal to nominate Mr Ární Páll ARNASON as Member of the Board of Regulators, as replacement for Mr Hogni S. KRISTJANSSON,

HAS ADOPTED THIS DECISION:

Article 1

Mr Árni Páll ARNASON is appointed as Member of the Board of Regulators, in representation of the EFTA Surveillance Authority (ESA).

Article 2

This Decision shall enter into force on the day of its adoption and shall be notified to the Board of Regulators and to Mr Árni Páll ARNASON.
