1 Opening

Welcome address and introduction of the present participants. The Agency presented the current status of the implementation of REMIT, including the Commission's implementing acts and policy documents related to data collection currently being prepared by the Agency.

2 Draft XML schemas for the reporting of standard and non-standard contracts

The most recent draft of the XML schemas for the reporting of standard and non-standard contracts was presented and discussed.

In general, the participants of the meeting supported the draft XML schemas. The Agency maintained its position that the schemas developed by the Agency will be the only schemas acceptable for the purpose of reporting under REMIT. Some of the participants provided detailed technical feedback on the schemas. The Agency will take the feedback received into account in the further work with the schemas.

3 Draft XML schemas for the reporting of electricity and gas transportation contracts

The most recent draft of the XML schemas for the reporting of standard and non-standard contracts was presented and discussed.

As regards the XML schemas for the reporting of electricity transportation contracts, ENTSO-E suggested to use the schemas based on the IEC standard and currently used by the TSOs, arguing that this would limit the burden on TSOs. The Agency will continue discussions with ENTSO-E and other relevant stakeholders on this topic. No comments were provided related to the XML schemas for the gas transportation contracts.

4 AOB and way forward

The meeting participants appreciated the opportunity to discuss the XML schemas. A public consultation on the schemas was not considered necessary, however the stakeholders would welcome further discussions on the XML schemas once the schemas have been mapped to the trading scenarios. Further information was also requested on interfaces and on timelines for testing. The Agency intends to organise a public workshop in the course of December to provide information related to data reporting under REMIT.
