- The European Parliament ITRE Delegation will visit the Agency on 21 September.
- Discussion sessions will focus on:
 - » Activities of the Agency and the challenges it faces

15 March – 30 April, ACER consultation on the Interoperability Implementation Monitoring

- Following the entry into force on 20 May 2015 of the Network Code on interoperability and data exchange rules, the Agency is preparing the first **report** on the implementation of the Balancing Network Code.
- The Agency issued a **survey** through which it gathered stakeholders' views on implementation and issues relating to interconnection agreements, gas quality and odourisation, and data exchange. Overall, no systemic problem was reported.

3-4 May, the Network Code Conference

- The European Commission, ACER, ENTSO-E and ENTSOG jointly organised a conference in Brussels to discuss the achievements and challenges relating to the implementation of Network Codes and Guidelines, with the participation of Commissioner Miguel Arias Cañete.
- The Conference was well attended with over 300 registered participants and raised awareness about the importance of timely implementation of the Network Codes and Guidelines.

15 May, ACER Workshop on Within Day Obligations

- ACER organised this workshop in the context of the Gas Balancing Code implementation.
- The workshop focused on within-day obligation balancing regimes and getting stakeholders' views on the functioning of these regimes.

29 June, ACER Annual Conference

- The Annual Conference of the Agency was held in Brdo Congress Centre and attended by around 150 participants.
- Entitled "Regions for the Internal Energy Market," the Conference was structured in three sessions focussing respectively on: which aspects are best dealt with at regional level; the geographical scope of regional cooperation; and governance and regulatory aspects.

24 August, ACER consults on maximum and minimum prices in the day-ahead and intraday coupling

- As of August 2017 the Agency has become competent to decide on the proposals for maximum and minimum prices in single day-ahead and intraday coupling developed by all Nominated Electricity Market Operators, and is currently consulting on the amendments it proposes.
- All interested stakeholders have been invited to submit their comments by 15 September.
- The decision on the two proposals will be taken in accordance with the EU Regulation on Capacity Allocation and Congestion Management for electricity.

11 September, ACER Workshop on Harmonised Allocation Rules for long-term electricity transmission rights

- The Agency organised a workshop in Ljubljana on 11 September on the main body of the Harmonised Allocation Rules (HAR) for long-term electricity transmission rights submitted by all TSOs in accordance with the EU Regulation establishing a Guideline on Forward Capacity Allocation.
- The National Regulatory Authorities did not reach agreement on the required credit rating for banks issuing collaterals for market participants and have requested ACER to take a decision.
