## ✓ ACER Annual Conference 5 July – Kranj, Slovenia

The Conference opened with a welcome address by the Slovenian Minister of Infrastructure, Peter Gašperšič, and a presentation on the priorities of the Austrian EU Presidency in the field of energy by Andrea Steinmetz, Deputy Head of Department of the Austrian Ministry for Sustainability.

There was a live connection with European Commission Vice-President for the Energy Union, Maroš Šefčovič, who highlighted that the EU aims at ensuring an energy system aligned with the high-pace technological change, and he stressed the relevance of the work of the Agency in order to achieve that goal. He added that the EC therefore has insisted on expanding ACER's mandate.

There were also video messages by Commissioner for Climate Action and Energy, Miguel Arias Cañete and Dominique Ristori, Director General for Energy of the European Commission.

Discussions were structured around three themes: the "smart" future of the energy sector, opportunities for sector coupling for a better utilisation of renewable energies, and pricing in the EU energy market. The three thematic sessions were moderated by Dr Romana Jordan, Chair of ACER's Administrative Board, Mr Andris Piebalgs, Chair of ACER's Board of Appeal, and Garrett Blaney, Chair of ACER's Board of Regulators.



## ✓ ACER appearance at ITRE Committee

On 16 May, an exchange of views with ACER took place at the European Parliament's ITRE Committee in Brussels. The Director and the BoR Chair presented the Agency's recent activities, the main challenges facing the Agency and the impact of the Clean Energy Package on the Agency.

Two key messages were conveyed with regard to the main challenges and the impact of the Clean Energy Package Package on the Agency.

- » Budget: The Agency requires sufficient budget in order to fulfil its mandate of market surveillance of wholesale energy markets, including through the charging of fees.
- » CEP: Concerns were expressed with regard to positons reached during the interinstitutional debate which reflect a step backwards from the building blocks of the Third Package with regard to the Agency's powers and the institutional balance within ACER.



## ✓ Forward-looking initiatives and taking stock of the CEP

An internal BoR workshop was held on 13 March regarding the future challenges to the Internal Energy Market (IEM) and the key objectives for the future EU energy market. A holistic, whilst non-conclusive, discussion was initiated on key electricity, gas, and cross-sectoral challenges which will feed into the 2<sup>nd</sup> BoR Summit which will be organised at a later stage after taking stock the new CEP framework.

The electricity session focused on: adequate zone/price configuration, maximising available cross-border capacity, security of supply, adequacy and price signals, and the governance and structure of ENTSOs and NEMOs.

The gas session focused on: managing the transition towards a low carbon energy system (gas as a bridge technology, the use of new gas and hydrogen technologies), future gas scenarios and uncertain demand scenarios (new investments, stranded assets, increased up stream market power).

The cross-sectoral session focused on: electricity and gas sector coupling; at wholesale level, but also beyond, such as on the interlinkages between network and market, retail and wholesale, and demand-side response.



#### 19 June 2018, Ljubljana, Slovenia Workshop on ACER decision for a booking platform at the German-Polish border

 ACER organised this workshop to gather input for its decision to select a single booking platform for the German-Polish border. The NC CAM requires that one single capacity booking platform is selected on two sides of an IP. On 19 April 2018, the Agency was called upon by German and Polish NRAs to adopt a decision on which booking platform to use at the border between the Gaspool market area (GASCADE and ONTRAS) and Poland (GAZ-SYSTEM). The decision is expected by 19 October 2018.

#### 18 June 2018, Brussels, Belgium

Workshop on the estimation of the cost of disruption of gas supply (CoDG) and the value of lost load in power supply systems (VoLL) in Europe

 ACER has contracted studies to develop methodologies which allow the evaluation of CoDG and VoLL in monetary terms per EU Member State per type of consumer or, if not feasible per Member State, at regional level. The workshop's key sessions focused on 1. Review of approaches, 2. Highlights of the methodologies for VoLL/CoDG/SoS, handling of parameters, uncertainty, 3. Results of the methodologies application, main findings of the studies, and recommended approaches.



#### 12 June 2018, Brussels, Belgium ACER-ENTSOG Joint Workshop on The Implementation of the Balancing Network Code

- ACER and ENTSOG, with the collaboration of Eurogas, CEDEC and GEODE, held their fourth joint workshop on the implementation of the Gas Balancing Network Code in Brussels. The aim of the workshop was to foster the knowledge-sharing across the Member States and to support implementation and the development of good practices. This year the full day workshop focused on information provision and covered thematic sessions on:
  - Forecast models, Non Daily Metered forecast
  - Issues related to Data Frequency and Accuracy.

#### 8 February 2018, Brussels, Belgium

Stakeholder event on ACER report on methodologies and parameters to determine gas TSO revenues

 ACER organised a stakeholder event on methodologies and parameters to determine gas Transmission System Operators revenues. During the event, participants were invited to express their views on the scope of this work. The event was open to stakeholders, TSOs and NRAs. In accordance with the network code on rules regarding harmonised transmission tariff structures for gas, the Agency has to publish a report. This will include the input gathered at this event.
