
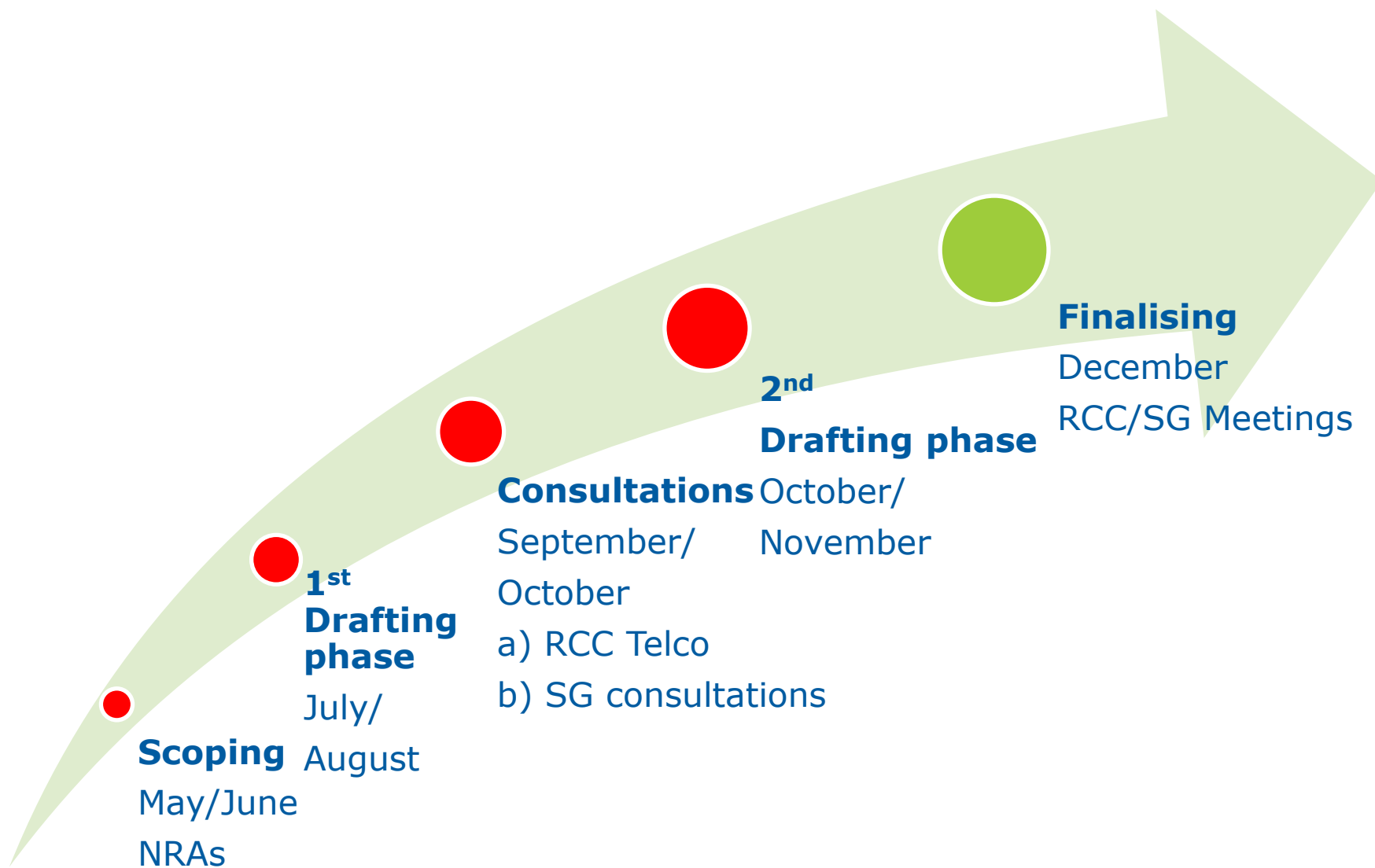

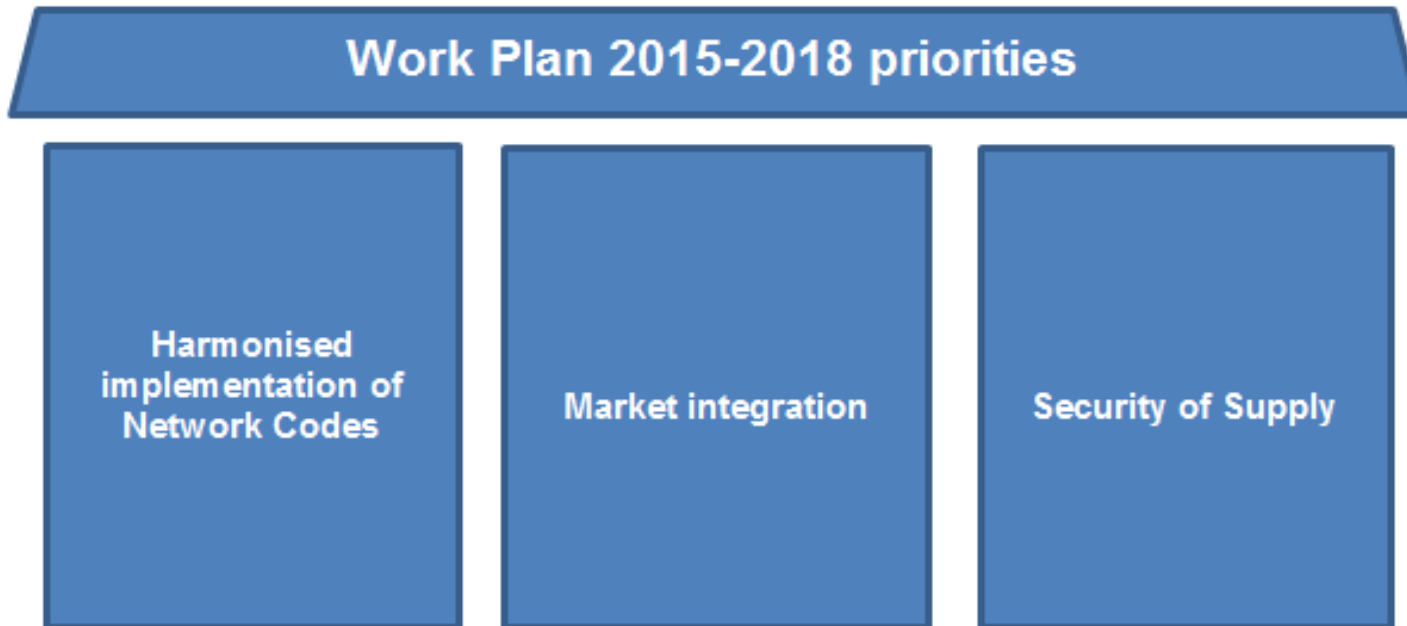





ACER guidelines for GRI cooperation.
