

# One year on from the “Bridge to 2025” and heading towards an Energy Union

The “Bridge to 2025” is a formal Recommendation from ACER (in close cooperation with CEER) to the European Parliament, the Council and the European Commission which was issued on 19 September 2014.

## ***In the Bridge, we noted:***

- ❖ The challenges Europe’s energy markets will face in the coming ten years. These must inform the energy regulation agenda and we made several recommendations
- ❖ The completion of the IEM and implementation of the Target Models are designed to achieve liquid, interconnected electricity and gas markets, along with consumer rights, energy efficiency and market integrity measures. These will continue to be our central priority



## ***In the Bridge, we committed to:***

- ❖ Continuous process (not an event) with full engagement of all stakeholders in developing a strategic and holistic view of developments across Europe’s gas and electricity markets to the benefit of consumers
- ❖ The development of proposals in full dialogue and consultation with the energy sector and the European Institutions and regular review and strengthening of our conclusions and their implementation

## ***One year on:***

- ❖ In the wake of the launch of the Energy Union strategy, we should continue our dialogue with consumers, stakeholders and all energy actors, as well as European Institutions in order to meet the future challenges and to take appropriate action to help to deliver the Energy Union strategy ....
